




# MUNICIPAL CORPORATION, HOSHIARPUR

## Terms and Conditions E-tender No.: LGMCORP/2017-18/

- (a) Interested/Eligible Bidders can purchase the tender documents online from website. [www.etender.punjabgovt.gov.in](http://www.etender.punjabgovt.gov.in).
- (b) Bidders have to pay the processing fee, cost of tender form and Earnest money through online mode (E-payment) only. No other mode of payment will be accepted. Tenders of agencies failing to pay concerned fees online shall not be considered and agencies'll be sole responsible for the rejection of tenders in such case.
- (c) Bidders/ Contractors shall download the tender documents from the website mentioned above, fill them and submit the completed tender document into Electronic Tender/mode on the website itself. Bidders/Contractors shall upload scanned copies of all the paper, i.e. PAN No. GST No & EPF No. Enlistment Record, any other required document as required in terms and conditions.
- (d) Corrigendum/Addendum/Correction, if any will be published on the website only.
- (e) NIT and term and conditions are being uploaded at the [etender.punjabgovt.in](http://etender.punjabgovt.in) only for viewing. Agencies should note that online tenders will only be submitted at the aforesaid website i.e. [www.etender.punjabgovt.gov.in](http://www.etender.punjabgovt.gov.in) (Being uploaded shortly) as per the details/instructions uploaded therein.
- (f) The bidder/Firm should have EPF Number, GST Number and PAN Number.
- (g) If at the time of submission of e-tender, any error occurs due to technical reason of website, Municipal Corporation, Hoshiarpur will not responsible.

- (i) Only those tender will be open which will fulfill eligibility criteria.
- (j) Quantity of the estimated items may vary.
- (k) If holiday is declared on the date of tender then tenders will be received/opened on next working day.
- (l) Commissioner, Municipal Corporation reserves the right to cancel/reject any/all tenders without assigning any reason.
- (m) The Co-op L/C societies/ agencies shall strictly furnish the requisite documents such as Capacity certificate, Enlistment certificate/ document with Punjab PWD Deptt. Renewal, certificate regarding never blacklisted/ debarred/ banned and other documents required as per notification no. 76/52/79-C.1(5)/5024 dt. 11.07.2011 and subsequent amendments thereon as scanned along with the e-tender
- (n) Preference will be given to the co.op. L/C Societies (Registered in State of Punjab) for the works up to 40.00 Lac. The tenders of the L/C Societies for the works up to 40.00 Lacs will be opened on the same day. Initially, only tenders of the L/C Societies (up to Rs 40.00 Lacs) shall be opened and if in case after opening of tenders, the department observes that the tender quoted by L/C Societies do not qualify as per norms, only then, the tenders of contractors/agencies participated in tenders, if any, shall be opened.
- (o) Only BIS approved and ISI marked Interlocking Tiles'll be used in civil works.
- (p) Steel in the civil works will be used of Tata, Sail, RINL, Jandal or IISO make only.
- (q) Agency should have to use PVC pipe 6" dia ISI marked and of make either of Parkash, phenolex or prince.
- (r) For work at S.No. 2, 4, 5, 6, 7, 8, 9, 10, 11, 12 **only Manufacturers / authorized dealers/ authorized suppliers of concerned labours/material shall participate in tenders. Supporting documents must be uploaded on e-tender website along with price bid.**
- (s) Agencies must sign and upload the Terms and conditions duly signed and rubber stamped along with other Tender documents. **MW-3 or MW-4 as the case may be uploaded by the Contractor/Agency duly signed along with tender documents.**
- (t) Work Order will be issued after the approval of resolution obtained from The Competent Authority.
- (u) Barricading will be the sole responsibility of Contractor/agency as required as site.
- (v) In case work is not completed with in stipulated period, penalty will be imposed as per rules.
- (w) Informative boards regarding details of work as per Government Instructions shall be installed/painted at site before start of work. No extra payment for boards'll be paid to Agencies by Corporation.
